FIELD HOUSE RULES AND REGULATIONS

CANCELLATION/REFUND POLICY

1. The Field House reserves the right, prior to the first class or after, to cancel a class due to insufficient registration, with full refund.
2. There is a \$75 non-refundable registration fee included in the price of all youth classes at the Field House.
3. Requests for class fee refunds (not including the non-refundable registration fee and the fee for any classes taken) will be considered through the third class. No refunds are available for summer classes. All requests must be submitted in writing. No refunds or credits will be given after the third class. No refunds will be given when registering late in the semester. (Please allow 2-4 weeks for processing.)
4. Class fees are non-transferable.

YOUTH CLASS MAKE-UP POLICY

Students are allowed to make-up a maximum of two classes per semester. Make-ups for youth classes must be taken during designated "make-up classes" or during one of our Rock-n-Roll classes. Students will be required to pre-register for these classes through our Registration Office and enrollment will be based on availability. In addition, we will not be able to offer make-ups for missed make-up classes. Make-ups must be used during the semester in which the original class was missed.

MEDICAL RELEASE AND ASSUMPTION OF RISK: (FOR ANY STUDENT PARTICIPATING IN A CLASS)

By the very nature of sports, gymnastics and other activities available at THE FIELD HOUSE AT CHELSEA PIERS carry a risk of physical injury. No matter how careful the participant and the coach are, no matter how many spotters are used, no matter what height is used or what landing equipment utilized, the risk cannot be eliminated. The risk of injury includes minor injuries such as bruises and more serious injuries such as broken bones, dislocations and muscle pulls. The risk also includes catastrophic injuries such as permanent paralysis or even death from landings or falls on the back, neck or head. Sports, gymnastics, or any activity that involves motion, rotation and height in a unique environment, carries with it a reasonable assumption of risk.

THE FIELD HOUSE AT CHELSEA PIERS is bound by law to inform all participants and/or their guardians of the risk involved in the activity of gymnastics and sports in general. Anyone participating in THE FIELD HOUSE AT CHELSEA PIERS programs must sign the notice on the application, and adhere to the safety rules governing THE FIELD HOUSE. These rules are posted inside THE FIELD HOUSE. In consideration for THE FIELD HOUSE AT CHELSEA PIERS' acceptance of the applicant, and in consideration of the applicant's opportunity to improve skills through the use of THE FIELD HOUSE AT CHELSEA PIERS' staff, equipment and facilities, those legally responsible for the named enrolling student realize the risk of injury involved and hereby agree to assume the responsibility of such for said student and further agree to save and hold harmless Chelsea Piers L.P., its employees, and all others concerned, and to indemnify them against loss, intending to be legally bound.

I certify that the enrollee has no condition that prohibits full participation in the activities at THE FIELD HOUSE AT CHELSEA PIERS. I assume all ordinary risks when using the facilities and hereby release THE FIELD HOUSE AT CHELSEA PIERS, or any of its employees, for any injury or damage suffered in connection with said use of the aforementioned facility and its equipment. In case of emergency, if I cannot be reached, I authorize THE FIELD HOUSE AT CHELSEA PIERS, its agents and employees, to contact and secure necessary medical attention for me or my child.
